Dog Owner Agrees

1. I am entrusting my dog(s) to Creekside Dog Days LLC for day care and/or boarding.
2. I will provide a hard copy OR my veterinarian will email proof of vaccination before my dog's first stay.
3. My dog(s) is/are dog-friendly and human-friendly.
4. My dog(s) is/are non-aggressive and non-guarding (protective) of food, people or objects.
5. My dog(s) will be healthy upon arrival and will be free from fleas, ticks, lice, parasites, and kennel cough.
6. My dog(s) will enter and exit the Creekside Dog Days LLC greeting area on a leash.
7. Photos/videos of my dog may appear on Creekside Dog Days LLC's social media accounts and/or website.
8. I will render payment on the day of pick up from daycare or boarding.

9. Veterinary Care: In the event that my dog(s) should need veterinary services, Creekside Dog Days LLC will consult a veterinarian of their choice, likely Banks Veterinary Services. (We will try to contact you first.) I, the owner, request that the following wishes are honored (please initial):
____ Save my pet regardless of the cost of any necessary treatment, medication, or surgical procedures.
____ Use any and all reasonable and customary treatments, medications, or surgical procedures necessary to treat my pet, not to exceed \$_____.
____ Owner does not want my pet treated by a veterinarian under any circumstances, even in a life-threatening situation.

10. Veterinary Services Liability: I, the owner, agree that I am fully responsible for any and all costs of veterinary/medical treatments provided to my dog(s) and that I will pay all expenses promptly.
11. I will assume full responsibility for any harm or damage caused by my dog(s) while on the premises or under the care of Creekside Dog Days, LLC.
12. Acknowledgement of Risk: Due diligence is made to screen each dog attending Creekside Dog Days LLC. Each owner has attested that their dog's behavior meets our standards of dog-friendly, human-friendly, non-aggressive and non-guarding animals. Please remember, a.) Whenever dealing with animals, there is a risk of unpredictable behaviors. b.) Free range play may result in injuries or exhaustion from overexertion, rough play, insect stings/bites and may include sore feet, sore tails, or ingestion of sticks or other items found outside.
13. I understand and agree that in admitting my dog(s) to Creekside Dog Days, LLC, the owners of Creekside Dog Days, LLC have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggression or threatening behavior toward any person or any other dog.
14. Creekside Dog Days LLC reserves the right to dismiss, at our discretion, any dog from daycare/boarding for aggressive or dangerous behavior.

15. I hereby release, waive and discharge, Creekside Dog Days, LLC, its staff, sub-contractors and volunteers from liability for any and all loss or damage, and any claim for damages resulting therefrom, on account of injury, loss, damage, ailment or disease to my dog(s), even resulting in death, while my dog(s) is/are under the care of Creekside Dog Days, LLC.
16. I will pick up my dog(s) at the end of the day by 6:30pm or the end of the agreed upon boarding period. Additional fees may apply if pickup times are not met. (6:30pm for daycare and 12:00pm for boarding).
17. I understand that if my pet is not picked up within four (4) days of the scheduled pick up date, and if I have not communicated with Creekside Dog Days, LLC, the dog(s) will be deemed abandoned and additional boarding fees will apply. In case of abandonment, Creekside Dog Days, LLC will gain legal custody of the dog(s) and has the right to keep the dog(s), place the dog(s) in a new home, or release the dog(s) to a shelter or animal control.
18. I understand that Creekside Dog Days, LLC is caring for my dog in good faith and will make every effort to care for my dog in a loving, caring, and responsible way. Every attempt will be made to quickly resolve any negative occurrences to maintain positive interactions and relationships in the future.

Daycare Fees: \$27.00 full day; \$18 half days (up to 6 hours) No additional fees for lunch feeding or medications. (please provide detailed medication instructions if applicable.) Drop off at 7am or later and pick up by 6:30pm. Pickups after 6:30 will be charged a late fee of \$5.00 Half day daycare will be charged a full day of daycare if play time exceeds 6 hours.

Boarding Fees: \$40.00. Drop off before 11am on the first day of stay and pick up by noon of pick-up day. May arrive earlier than 11am, but full day care charges may be applied if pick up is after 12:00pm. Owner will provide food for their dog during their stay.
